

**TERMS AND CONDITIONS :-**

1. The eatable prepared / supplied by the contractor in the canteen should be of good quality / standard. In case, it is found that sub standard material is used in preparation / supply of above eatables, the Corporation shall be at liberty to cancel the contract besides imposing penalty for Rs. 5,000/- payable by the contractor.
2. The Caterer shall have similar experience of three years in the last seven financial year ending 2025-2026. The requisite certificate from the concerned establishment shall be attached.
3. The rates of eatables should be displayed on the Notice Board in the Canteen.
4. Canteen premises will be kept neat and clean.
5. No Kerosene Oil / Coal be used by the contractor in the Canteen premises. However, he will use LPG for cooking purposes. Gas is available but cost of refilling will be paid for by the contractor himself.
6. Catering services will be provided to the employees of the Corporation. No outsiders will be allowed to be entertained by the contractor in the canteen except with the prior approval of the Corporation. No private party / club meeting will be permitted in the office canteen.
7. The contractor will be permitted to sell eatables, meals and aerated cold drinks, tea and coffee only, which have been approved by the Corporation. The rates for these items can be revised by constituting a committee in case of extraordinary fluctuations in rates.

8. The contractor will not sell any item containing tobacco, alcohol or any other prohibited items in the canteen. Neither any person will consume alcohol or cigarette in the canteen.
9. The canteen will observe the following hours of working on all working days of the office from 8.00 AM to 6.00 P.M. On requirement, the dinner shall be upto 10.00 P.M. The Caretaker shall inform the caterer in advance before 5.00 P.M.
10. The contractor will ensure high standard of hygiene and sanitation in and around the canteen round the clock. Disposal of solid and liquid wastes will be responsibility of the contractor.
11. The contractor will furnish a list of workers employed in the canteen. The contractor will himself be responsible to get verified their character and antecedents.
12. Any loss occurred to the Corporation due to negligence of the contractor or his staff, shall be made good by the contractor.
13. The workers employed by the contractor will wear proper prescribed uniform.
14. Contractor will use the items of reputed make conforming to relevant food standards.
15. The M.D. HPHC Panchkula shall have right to cancel the contract by issuing an office order without giving any reason and the contractor will vacate the canteen premises on a week's notice.
